# The Disney Collage Program at Delaware State University

The Disney College Program at Delaware State University for International Students is known as International Attractions & Tourism Program. The International Attractions and Tourism Program is a unique program offered by Delaware State University's College of Business that includes a working and learning opportunity with Walt Disney World International Programs. Students from across the globe take part in credit-earning studies, combined with the Leisure and Tourism experience on the campus of Delaware State and the Walt Disney World® Resort in Orlando, Florida.

# Why participate?

#### Why participate in the DSU International Attractions and Tourism Program?

Students in the International Attractions & Tourism Program will experience:

- A full-time internship with the company ranked the best place to start a career the Walt Disney Company.
- A U.S. college experience earning 12-15 college credits <u>per semester</u> at the highly regarded, AACSB accredited College of Business at Delaware State University.
- Approximately 3 weeks in the Mid-Atlantic area, studying at Delaware State University including intensive instruction in business with experiences at top tourist attractions in the region.
- The opportunity to participate in many professional development activities and training programs at the Walt Disney World® Resort.
- A professional, high quality program that supports international students as they apply for visas, travel to the United States, study, participate in field experiences, live and work at Walt Disney World®.
- Students that successfully complete their course work will receive a certificate in International Attractions and Tourism Management from Delaware State University. Students that successfully complete their internships will be issued a Ducktorate certificate of completion from Disney.

#### The Program

The International Attractions and Tourism Program includes:

- <u>The Academic Component</u> Coursework resulting in 12-15\* college credits <u>per semester</u>.
- The Walt Disney Internship

  A 6 month full-time internship at the Walt Disney World® Resort in Orlando, FL.

#### **The Academic Component**

The Academic Component is a 12-credit/semester program that includes coursework at Delaware State, coursework at Disney and a supervised internship. It includes:

- 41-440 International Management, 3 credit hours.
- 41-435 Entrepreneurship, 3 credit hours.
- **45-108 Introduction to Tourism Management,** 3 credit hours. This course may be substituted by an ACE course at the Walt Disney World® Resort.
- One 3-credit course from a choice of ACE accredited courses, optional. This course is offered at Walt Disney World®. These courses typically meet once a week for 4 hours over 11 weeks.
- 41-490 A Supervised Internship at the Walt Disney World® Resort. The special assignment will include some exercises and assignments in the academic component for students to gain exposure to the duties and responsibilities of professionals in these departments (like a day where students "shadow" a manager or executive to write a paper). These assignments will be assigned by DSU. 3 credit hours.
- In addition to the 12-credit International Business Program, students have the opportunity to earn an additional 3 DSU credits for no extra charge through coursework completed at Walt Disney World®. Upon successful completion of their coursework, students will be issued a transcript from Delaware State University.

# The Walt Disney Internship

Students in the IATM program will participate in a full-time (30-45 hours a week) internship at the Walt Disney World® Resort, earning a minimum of \$9.00 an hour. Students have a choice of a wide variety of choices of jobs (called "roles") for their Disney internship including demonstrating and selling merchandise, life guarding, working in housekeeping, hospitality, recreation, operations, and positions in food and beverage operations.

As part of their internship, students receive world class training at Disney, including Traditions (an introduction to the company's heritage, culture and standards), line of business training, property orientation, and on the job training. Additionally, there are many other training and professional development activities students can participate in at Disney including the professional development series, Disney Exploration series, Conversations With/Career Insights/

Spotlight On lectures, My Disney Career Series, College Alumni Speaker Series, and many online learning offers targeted on improving career-related skills.

# **Delaware State University Required Course information:**

#### 41-440 International Management

A survey of the major issues which face a manager operating in an international environment is the focus of this course. The aim of the course is to examine how different national and cultural environments affect the way that multinational companies (MNCs) operate from one counter to the next. Credit, 3 hours.

#### 41-435 Entrepreneurship

This is an applied course, and students are expected to work in small groups to create and to implement a new venture idea. Credit, 3 hours.

#### **45-108 Introduction to Tourism Management**

This course is designed to provide the students with basic knowledge of tourism and travel related concepts and with the practical experience that will enable them to effectively apply those concepts to the hospitality industry.

# 41-490 Internship

Completion of a Supervised Internship at the Walt Disney World® Resort. Credit, 3 hours.

# Costs, fees and other requirements

The cost payable to Delaware State University to participate in the International Attraction and Tourism Program is \$5,500 for the one-semester program. This includes:

- Transportation from the Philadelphia International airport to DSU, if arriving on the planned schedule.
- Housing accommodations for the Delaware component of the program.
- Most meals while in the Delaware area: all breakfasts, lunches and dinners on class days, and some other meals on trip days. Some meals during the field trips are "on your own" and paid for by the students.
- Tuition and fees for 12-15 credits per semester from DSU.
- Airfare from Dover, Delaware to Orlando, Florida.

#### Costs covered by the students:

- Living expenses an apartment and meals while at Disney World. The cost of the apartment (i.e., "rent") is approximately \$75-\$97 a week.
- Airfare to and from the country of origin.
- Baggage fees and MEARS shuttle fee from Orlando airport to Disney Vista Way.
- Health insurance for the duration of the program.
- Some meals during field experiences.
- Textbook and course material fees.
- Disney program assessment fee (\$350).
- Costs associated with visa application.

*Note: Disney fees are paid through payroll deductions.* 

## Other requirements

To participate, students:

- Have active student status in a university outside of the United States
- Be 18 years of age or older
- Have a good academic standing
- Pass a background check at their local police station
- Recommended by school
- Have English language proficiency acceptable to Delaware State University
- Pass an interview from DSU and Disney staff
- Have adequate documented financial resources to meet visa requirement

### J-1 Visa Information

### For Students in the Delaware State Disney College Program

As Delaware State University Students with the J-1 exchange student visa status, you are required to follow the United States regulations governing your status.

#### **Important Documents:**

Keep these documents in a safe place at all times.

#### Passport

A Document issued by your home government. It is required for all international travel and is considered to be your official identification document outside of your home country.

#### DS-2019 Form

This is the basic document that allows you to apply for the J1 visa and is proof of your legal J-1 status in the United States. You will receive two DS-2019 forms, the first one you used to apply for the J-1 visa travel into the U.S. and a second one that you will receive after you arrive on our campus that has been signed in the lower right corner for travel outside the US including cruise travel. Attach both DS-2019 forms together and use both of them for any future travel.

#### I-94 Card

This small white card was stapled into your passport when you entered the United States and is official proof of your J-1 status. The notation of D/S (which stands for Duration of Status) on the I-94 card indicates the time you are allowed to remain in the U.S. Look on your DS-2019 form item 3 to find the ending date of your time to remain in the U.S.

# **Full-Time Enrollment Required**

You are required to maintain full time enrollment (12 credits for more) throughout your stay in the Program. Do not withdraw from a class if the withdraw will result in less than a 12 credit course load.

#### Travel Abroad and Reentry to the United States in J-1 Status

If you wish to travel outside of the United States and then re-enter the U.S. during your J-1 program, you must be prepared to present the following documents to the Officials at the U.S. Port of Entry:

- Valid Passport
- Valid J-1 Visa in your Passport (You do not need a valid J-1 visa to reenter the U.S. from Canada or the Caribbean Islands if your visit there lasts less than 30 days)
- Valid DS-2019 form with a current signature in Travel Authorization Box in the lower right corner of the DS-2019 form.

You will receive a second DS-2019 form after you arrive on campus and it will be signed for any travel outside the U.S. you may want to make during your time at Walt Disney World.

# Program Completion and the 30-Day Grace Period Following the Completion of the J-1 Program

The beginning and ending dates of your J-1 program are listed on your DS-2019 form, item 3 and you will be expected to move out of your accommodations on your ending date. However, the J-1 regulations allow you to remain legally in the United States for an additional 30 days following your program end date. This is called the 30-day grace period. You are allowed to stay in the U.S. during this 30-day grace only for the purpose of visiting or doing sightseeing travel. You are not allowed to continue working during this time. Therefore, you may depart the United States anytime between the ending date as listed on your DS-2019 form item 3 and 30 days beyond that date.

Please note that after your program end date, you will be responsible for of all your own expenses including housing and meals. You must depart the United States no later than 30 days past your program end date. To remain in the U.S. beyond this date will be considered a violation of your legal status.

# Medical Insurance during the 30 day grace period

The medical insurance coverage that you have during your Delaware State Disney College Program will end on the program end date indicated on your DS-2019. If you plan to stay beyond the end date, you must also extend your insurance coverage. You will be responsible for the cost of additional medical insurance after your DS-2019 end date.

### J-1 Exchange Visitor Visa 2-Year Residency Requirement (212(e))

As a J-1 Exchange visitor, you may be subject to the two-year home country residence requirement (212(e)) which requires that you must "reside and be physically present" in your

"home" country for total of two years before being eligible for certain immigration benefits. Check your J1 visa and your DS-2019 to see if you are subject to this requirement.

- 1. You are not eligible for an immigrant visa or for adjustment of status to lawful permanent resident (immigrant/green card) status.
- 2. You are not eligible for an H visa (temporary workers and dependents), or an L visa (intracompany transferees and dependents).
- 3. You are not eligible for a change your nonimmigrant status within the United States from J to any other nonimmigrant category except A (diplomatic) and G (international organization) statuses.

# Changing Your J-1 status to F-1 Student Visa Status for Studies as a Matriculated Student (Degree Seeking) at Delaware State University

If you are interested in applying to Delaware State as degree-seeking student, you will be required to follow all admissions requirements and obtain the F-1 student visa, the appropriate visa required for full time matriculated students in the United States.

If you are subject to the 2-Year Residency Requirement (see above), you will be required to return to your home country before you begin your degree studies in order to apply for the F-1 visa at the U.S Consulate. This is due to the fact that the 2-Year Residency Requirement regulation prohibits you from changing your status from J-1 to F-1 within the United States. You must leave the United States, apply for the F-1 visa in your home country and enter the United States in time for your degree studies in valid F-1 status. Therefore, due to the time restraints, it will not be possible for you to begin your studies as a degree student immediately after your Disney College Program ends. Rather there will be a delay of one or two semesters before you can begin as a degree student.
